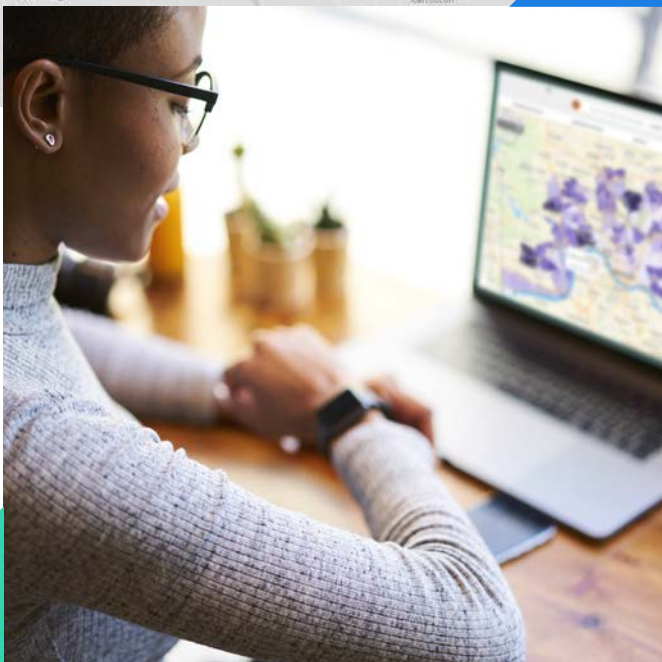
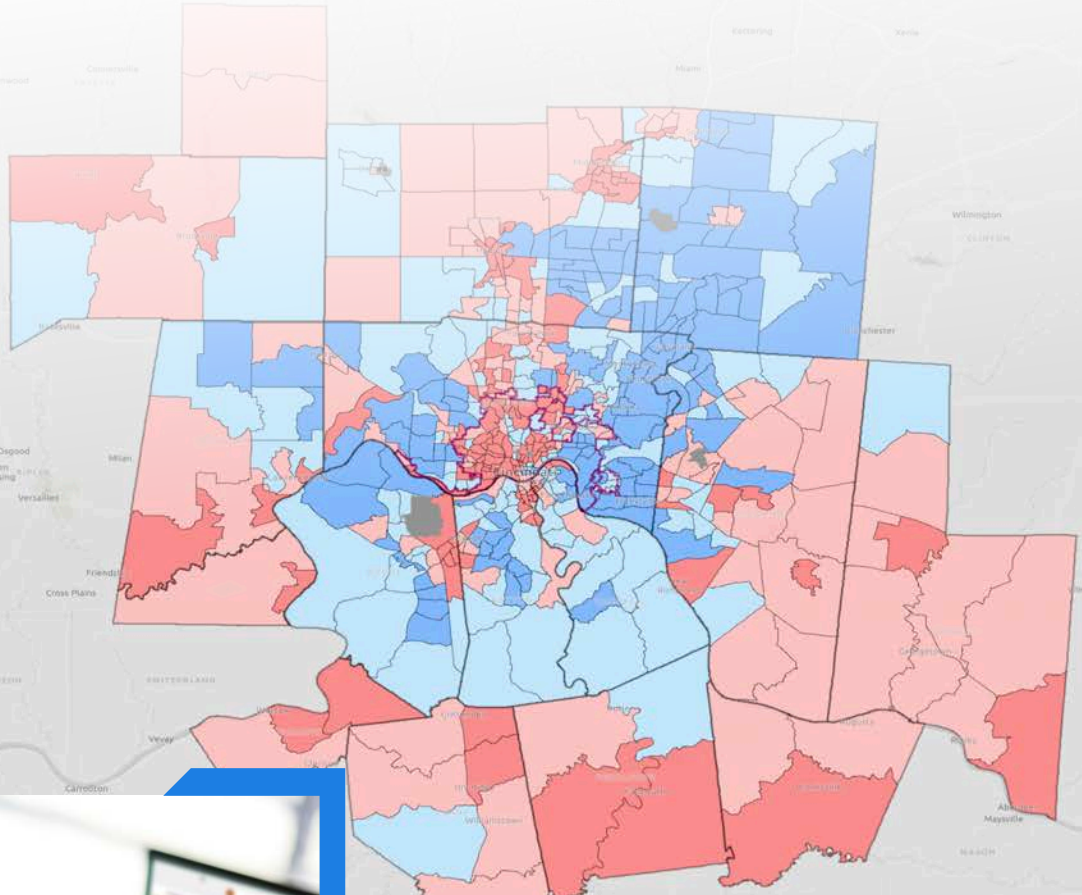

## Project LIFT

Unexpected expenses like car repairs or rent hikes can derail a family's journey toward financial stability. But there's hope.

Meet Danielle, a hardworking mother striving to provide for her son despite some challenges. Working full time, Danielle found it difficult to make ends meet. With the support of Project LIFT, she received crucial assistance with bills and rent, which kept her family from falling further behind financially.

Since its inception, Project LIFT has made a tangible difference, supporting more than 2,000 families like Danielle's. Our commitment to staying connected with families for at least a year is what sets Project LIFT apart. This ongoing support enables families to overcome obstacles, stabilize their lives and build a brighter future.

## Renew Collaborative

We're on a mission to help neighbors maintain a stable home – a safe, affordable place to live connected to a community of support. With your help, we make this a reality for families through the Renew Collaborative.

Through this eviction prevention model, advocates create custom plans for families to stay in their homes and negotiate directly with property owners to make payments toward back rent.

While eviction may seem like the simplest solution for property owners, it comes at a significant cost. Eviction can cost five times more than the expense of keeping the tenant in the home. Property owners can actually save money by financially supporting eviction prevention.

**Our help goes beyond eviction intervention; we identify the root causes of unpaid rent and provide ongoing services so families can get back on their feet.**

With your support, the Renew Collaborative is building stronger, more resilient communities where every family has the opportunity to thrive.





# How We Take Action

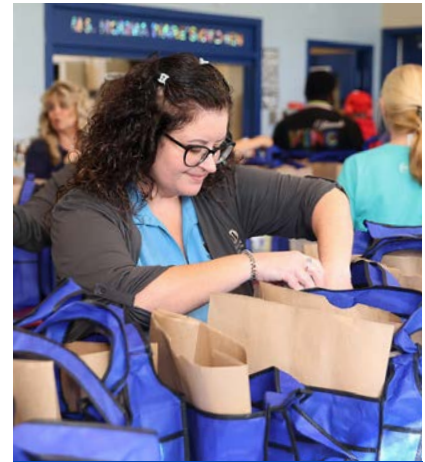
## Responding to Community Need

There's opportunity for everyone to be heard and to help move our community forward. We amplify the voices of those who've been underserved and ensure their input shapes our efforts. We also engage with partners and stakeholders from around the region who share their expertise and resources.

Because when we work together, there's no limit to what we can achieve for our community.

### Some of the ways we joined together to take action:

- 86 partners gathered to build five new solutions to launch in 2024.
- 21 community members trained to use storytelling for advocacy efforts.
- \$250,000 in grant funding earmarked to address early education gaps for families in Southeast Indiana.
- Your neighbors saved a collective \$2 million in tax filing fees and received \$8.7 million in refunds with help from Free Tax Prep volunteers.
- Expanded Project LIFT to serve Northern Kentucky and Clermont County.

## **Help is only one call away**

For almost five decades our 211 Helpline has evolved to meet the ever-changing needs of our community.

Today, 211 is more than a directory. It’s a compassionate lifeline, staffed 24/7/365 by empathetic professionals ready to assist people during their toughest moments.

With over 7,000 services available, finding help can be overwhelming. Families can find solace in these three digits. Our dedication doesn’t stop after the initial request. We’re committed to guiding neighbors to the resources they need to move out of crisis and on to a brighter future.

**Our impact extends beyond resource and service referrals. We use 211 data to provide real-time insights.** As our community’s needs shift, we have an early indication of barriers families face and gaps in services to meet those needs.

Thanks to your support, United Way’s 211 Helpline remains a lifeline for those who need it most, responding to more than 55,000 requests for help in 2023.



# How We **Advocate**

## Driving Systems Change Through Policy

We advocated for policies and initiatives that address the reasons families face financial difficulties, such as access to quality education, economic empowerment programs and affordable housing. We work tirelessly to support the well-being of all community members in our region.

### Our Success in 2023

- 55 advocates traveled to Ohio, Indiana and Kentucky state capitols to meet one-on-one with lawmakers.
- 15 parents traveled to Columbus to advocate for increased access to affordable childcare.
- \$154M in new funding for Ohio childcare and preschool, supporting nearly 12,000 children.
- Launched advocacy notes to make it easy for community members to connect with their elected officials.
- Hosted Ohio's Senate Select Committee on Housing as community members testified about affordable housing issues.
- Celebrated the 10th annual Live United Day by visiting policymakers at the Kentucky State Capitol in Frankfort.

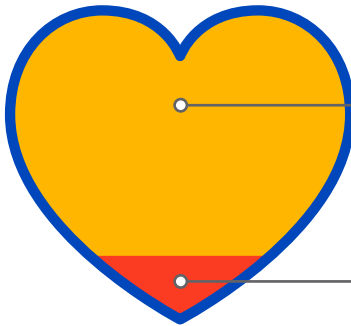
# How We Invest
